

Limited Non-Exclusive Copyright License for AFEQT™ Questionnaire

St. Jude Medical Business Services, Inc. ("SJM"), a corporation having a principal place of business at One St. Jude Medical Drive, St. Paul, MN 55117 has developed and solely owns all right, title and interest in and to the AFEQT™ Questionnaire and related materials (e.g., the Instructions for Data Collection and Scoring, data collections and compilations, etc), including any and all related copyright and trademark rights therein (collectively, the "Materials").

SJM is willing to allow third parties to reproduce, distribute and utilize such Materials under the following terms and each such third party ("Licensee") agrees that any use of the Materials shall be subject to the following terms. 1. 2. License Consideration:

- A. If Licensee is a pharmaceutical, medical device, biotechnology or other for-profit entity ("For-Profit") a one-time non-refundable license fee of Two-Thousand Five Hundred Dollars (\$2,500.00) for each protocol using the Materials to evaluate a product or service that is in development or presently available on the open market.
- B. If Licensee is conducting research at a not-for-profit institution ("Researcher") a one-time non-refundable license fee of Five Hundred U.S. Dollars (\$500.00) for each research project using the Materials.
